# **GINDALBIE - CLARIFICATION**

Gindalbie Metals Limited (ASX: GBG – "Gindalbie") released a corporate presentation to the market today which provided statements regarding the current status of reserves and resources in connection with the Karara Iron Ore Project. The ASX has asked Gindalbie to provide clarification of these statements to ensure compliance with the JORC code.
